Call to Order and Opening Comments

Bill Crawford – Mention that Dan Luther has resigned from Board of CCC and from CCDC and is pursuing other opportunities.

Police and Safety Report

Maggie Bower, CPD

- Report that crime is down over the past month.
- CPD is working on homeless camp cleanups in Inwood Park
 - Procedure for cleanups: CPD takes some representatives from Talbert House, or another social service organization, with them to the homeless camp to introduce the individuals to those who provide social services, and then come back a few days later to move people out of the camp.
 - Arresting individuals for returning to the site after they have been removed is the last option for the CPD.
- Resident Fran Larkin asked Officer Bower about a neighbor who called this past weekend with a noise complaint and said that there had been no response. His question was about what needs to happen when there isn't a response to a call.
 - Officer Sparks offered to go to the house and give a "Good Neighbor" talk to the students along with Officer Bower

UC Officer Cara Sparks

- 4/12/23 PAC concert on Sigma Sigma Commons
- 4/15/23 noon is Spring Football game. Sigma Sigma carnival 3 – 11pm.
- 4/19/23 UC is hosting Ohio Supreme Court hearings at Taft College of Law – all day
- Student move out 4/20 – 4/26 8 – 6pm every day. Officers will be working.
- 4/27 UC commencements begin, continue through 4/30 every day.
- 5/10 – 25 – 19 CPS graduations will be hosted.



Cincinnati Fire Officer D. Molitor

- Engineer company made 350 runs in March. 280 were medical calls.
 - 1 alarm fire – blazing fire. 5 1- alarm. 2 extra-alarm. 51 other calls/fire that are “other” – gas leak, etc.
 - 104 EMS calls
 - 42 less than 1-alarm fires. Overcooked food, etc. One room fire in household, etc.
- They respond to about one call a day on the highway – usually a medical problem, not a fire problem.
- Trends: nothing is standing out now in the types of runs they are making. Overdoses have been somewhat under control as there are a lot of resources out there right now.
- They are servicing fire hydrants right now to flush them out, dry them if they’re not being used, greasing them, etc.
- If you need a smoke detector battery, you should be able to go to your local fire department to get one. They don’t do childcare seat installations – go to children’s hospital for help on how to install these.

New Business

Bellevue Parking District

- Sally Dannemiller noted that she got a phone call today from DOTE that the parking district is “going away”. [Clarification – it is not]. She called Councilmember Lemon Kearney’s office, who worked with us to create the district, and spoke with an aid. There was a proposal to repeal the district but it did not pass City Council.
- Ed Wiethe – 237 William Howard Taft was sold to Uptown Properties. 8.6 acres. The property is going to be rehabbed. He also noted that The People’s Church has applied for PD zoning on their project, and is in the process of working towards that.

Old Business

- Good turn out, successful event.

CRC Report

- Rec Center day camp is not completely filled up yet.

Library

- Fingers crossed that the library will be open in June.
- Library is evaluating what they can complete after the library is re-opened, to get people back in ASAP.
- They will keep us in the loop about their re-opening party. They are open to working with local groups to help with the re-opening party event.



Burnet Woods – Presented by Rachel Wells and Sally Dannemiller

- Spring Fest / Earth Day April 22nd, 10 – 2
- CAC is organizing art. Bluegrass music. Yoga in the park. Wildflower hikes.
- The park board has a plan to daylight the creek in Burnet Woods.
 - Fourth Wednesday of Month at 4:30 is Burnet Woods Advisory Council
- Sewer system running through park is made of bricks and is outdated.
 - Combined sewer system, which leads to overflows.
 - If you are walking through Burnet Woods and smell sewer smells, there is a number to call.
 - Sub-group is trying to solve this issue with MSD.
- Wednesday in the Woods concerts through this summer.
- City is undertaking 90-day study of all artificial turf on city property. They are concerned about the PFAS chemicals in artificial turfs that are bad for people and the environment.
 - Preserve Burnet Woods has letter writing campaign about PFAS and lack of community engagement in the Dog Park decision making.

- Took vote on our proposed use of NSP – 10 votes approving.
