Police and Safety Report

CPD District 4 – Officer Sean Dent

- Statistics looking good for Corryville.
- Thefts from autos down from last year, thefts OF autos up though.
- Burglaries down, overall property crimes down over last year as well.
- CPD is working with UCPD and Uptown Properties to get access to student housing developments. Juveniles are breaking into these buildings and CPD needs to be able to access the buildings.
