Call to Order and Opening Comments

Police and Safety Report

Ladder 19 – Dean Molitor

- Trying to update all of their keys in lockboxes that allow them to gain entry without breaking doors or windows. A special keybox needs to be obtained by property owners.
- Primarily for commercial dwellings, multi-use dwellings. Can also be obtained by single family residential dwelling owners.
- Fire station doesn't keep entry codes to buildings on file because they change all of the time.
- They need to get access to buildings for fires as well as broken pipes, water damage, etc.

- Currently servicing hydrants – pumping them out so that they don't burst in the freezing weather and are still usable.

- Ability to divert NSP funds from approved expenses to efforts to address SNAP funding pause.
 - Discussion amongst community members about diverting funds and if so where to divert to.
 - Vote on diverting funds to Shop with a Cop and food pantries in neighborhood
 - Decision to split funds between Corryville Library, Corryville Rec. Center and St. George's food pantry.

Cincinnati Police Department – Victim Assistance Liaison (Monica K. Benton

- Individuals who work for the police and help them to file paperwork, working through processes.
- Can also help victims who have been impacted by violent crimes access funds (that are confiscated from drug busts, etc.) including for funeral costs.
- CROW – Cincinnati Respect our Witnesses – support for witnesses of a crime. Support for witnesses to crimes who come forward. Not Witness protection, but witness assistance.

Discussion of Deck collapse at Stetson square in October

- Proposal from community to have information from Corryville at the beginning of the semester on how to stay safe

Discussion of proposed Curfew on Short Vine for minors
